Please complete all information on the back page and return completed application to Thurgood Marshall Academy Public Charter High School either in person between 8am and 4pm, Monday through Friday or via email to admissions@tmapchs.org.

The application period will begin on January 4, 2010 and end on **March 31, 2010**. If there are more students applying than spaces available, we will conduct a public lottery on **April 6, 2010**. Notification letters will be mailed on April 6, 2010. Students who submit an application after March 31, 2010 will be considered for admission based on the availability of space.

CRITERIA FOR ADMISSION:

- Student must have completed 8th grade or equivalent to enter 9th grade, or meet all applicable transfer credit requirements to enter either 10th or 11th grade.
- Student must live in the District of Columbia and provide specific documents to verify residency.
- Student must submit a complete application.
- Student and parent/guardian must participate in an Admissions Workshop.
- We do not accept applications from new students who are 18 years of age or older.

APPLICATION INSTRUCTIONS:

- The application is to be completed by the applicant's parent/guardian.
- Upon completion, application should be either hand-delivered to the address below or sent via email to admissions@tmapchs.org.
- Applicants will receive an application receipt card to acknowledge receipt of their completed application.
- Notification of acceptance will be sent at the close of the application period.

ENROLLMENT INSTRUCTIONS:

- Student and parent must supply final year-end report card and all applicable academic records.
- Student will not be officially enrolled until all required documentation has been submitted.
