These additional documents are due on the day you return the enrollment packet. **Please note that the enrolling parent/guardian must be present when the enrollment packet and additional documents are turned in.**

1. **Birth Certificate** of student applicant. (Must show parent name)
2. Most recent **Report Card**
3. **Current Transcript** (10th and 11th grade applicants)
4. Parent/Guardian's **current and valid Government issued Photo ID (must include DC address)**
5. **IEP** (if applicable) a current and valid IEP must be submitted if student applicant is currently receiving Special Education Services
6. **Acceptable Proof of District of Columbia Residency** (Please provide **ONE** of the following)
 - A paystub-issued within the past 45 days
 - Must include current address and show that DC taxes are being withheld OR
 - TANF verification notice or recertification
 - Must be dated within current calendar year OR
 - Medicaid approval letter or recertification letter
 - Must be dated within current calendar year OR
 - Housing assistance letter or recertification letter
 - Must be dated within current calendar year
 - **Or you can provide BOTH your District of Columbia Driver's License AND Car Registration**
 - **Both documents must be unexpired**
 - **Names and addresses must match**
